

# THE AYLSHAM TWINNING 200 CLUB

The '200 Club' has operated from the 1st January 2004, as an extra means of fund-raising for Aylsham Twinning, with the added attraction of offering monthly and quarterly draws for cash prizes. Participation is independent from the Twinning membership and it is run separately with a dedicated bank account. In order to simplify the administration and avoid time-consuming collection of monthly subscriptions, membership is on an annual basis as explained in the Rules below. Results will be announced in the Aylsham Twinning Newsletter and will be on display at the Annual General Meeting of the Aylsham Twinning.

***The '200 Club' is not exclusive to members of Aylsham Twinning. Anyone (over 16) can join.***

## RULES OF AYLSHAM TWINNING 200 CLUB

The 200 Club will operate from the 1st January 2004.

The 200 Club will be administered by a treasurer appointed by the Twinning committee.

Membership of the 200 Club will be on an annual basis and will be open to non-members of Aylsham Twinning.

Subscription will be £1 per month payable annually at £12.00 per year in advance, renewable in each anniversary month of members' original subscription.

A record of all 200 Club members names, including prize winning, will be held by the treasurer.

Monthly/Quarterly draws will take place in the presence of at least 2 Twinning Officers and 2 other committee members.

Only members of the 200 Club whose subscriptions are currently up-to-date will be included in the draw.

Membership ('Share') numbers will be allocated by the treasurer.

Any member of the 200 Club (16 years of age or over) may hold as many 'Shares' as they wish to pay subscriptions for.

Monthly Prizes - These will be calculated, based on the total subscriptions held for that month, as follows:  
1 x 20%, 1 X 10%, 1 x 5%.

An additional Quarterly Prize will be drawn for 15% of the total subscriptions that have been held for the quarter in which it is drawn

All remaining funds raised by the 200 Club will be for the benefit of Aylsham Twinning, to help support future exchange activities. This will not be less than 50% of total subscriptions collected.

The 200 Club record books will be made available for the Twinning Committee as required and will be subject to annual audit.

The Aylsham Twinning 200 Club is licensed under the Gambling Act 2005 Schedule 11 part 5, and is registered with Broadland D.C.
